Minutes of Annual General Meeting

Held on Wednesday 8th May 2024 at 7.00 pm

1. Meeting opened by the Chair

Mark welcomed everyone to the meeting and explained the AGM procedure and committee structure.

2. Present and Apologies:

4. Matters Arising:

Mark went through the Annual Report (attached) and noted that the continued aim was to bring the community together, facilitating this by holding a range of events during the year from Pub Nights and the monthly Sunday Brunch to Talks on Gardening and Orangutans.

6. Treasurer's Report:

Jon presented the accounts for the year ended 31st March 2024, which have recently been completed by Sean. He outlined the main financial points, noting that although Income had increased, Expenses had also increased due to Improvements made to the Hall and increased running costs. Overall, there was a loss of over £3400.

£15000 is now invested in a one-year fixed rate bond, which will earn interest of around £950 and the CCLA account stands at over £7300.

The balance on the cash account fell due to cash payments made to the band at Riverside Rock and to Mary, the Hall's cleaner.

The Parish Hall expenses included the painting of the Hall, a new dishwasher, bike rack and laptop. A grant of £950 was obtained by Mark towards the purchase of the marquee. The heating costs were higher, although the timer is now more effective. The possibility of applying for Government grants to help with heating costs and other capital expenditure was discussed.

Jon noted that with higher expenses, it was important for the Parish Hall to retain as much of the funds raised as possible and suggested that future raffles should be in support of the Hall rather than other charities. Likewise with maintenance of the Parish Hall, it should be needed rather than desired.

A review of the Hall hire costs will be discussed in the following management meeting.

8. H&S Report:

Brian reported that regular monthly testing of the Fire Alarm System has been ongoing and a logbook maintained. Inspection of the Fire Extinguishers along with evacuation routes and signage, which are also done monthly, are in good order and in place. The Fire Extinguishers are serviced and maintained by West of England Fire Protection Ltd

As far as Brian is aware, there have been no entries in the Accident Book for the past 12 months.

There are seven elected Trustees, who all stood down. Maxine Difford confirmed she did not wish to stand for a further year and Julie Colquhoun has offered to stand as a Trustee and take over the role of Honorary Secretary. Nigel Sedgwick is also not seeking re-election as a Trustee.
