## Holding or Custodian Trustees

The Hall is vested in (or held by) the Holding Trustees/Custodian Trustee. Their responsibility is simply to hold the legal title of the Charity's property and to act on the lawful directions of the Committee in any transactions affecting this title. The Official Custodian of Trust is the Charity Commission.

(Note: The original Holding Trustees were Lady Stevens and Peter Townsend who originally signed the lease from the Parish Council (1999). As stated above as a charity the Charity Commission are now the 'Official Custodians'. At the time of lease renewal, (2034) the Committee will have to agree the signatures of the lease with the Parish Council, probably the Chair and Treasurer at the time.

# **Managing Trustees**

Managing Trustees are the members of the Management Committee, and are responsible for administration, events and the day to day management of the Parish Hall Charity, in accordance with its governing instrument (the Lease). Few problems are experienced providing the Committee members manage the affairs of the Trust with all reasonable care and attention, in the same way that they would manage their own affairs. Therefore, all Trustees are members of the Management Committee whether elected members, user group representative members or co-opted members
